1. Warning: You assume the risk of equine activities pursuant to Pennsylvania State law.
2. Upon my and all my minor children and/or wards' participation of horse riding or horse drawn activity, I acknowledge that the use, handling and riding of a horse or riding in a sleigh or other wagon or cart pulled by horses, involves a risk of personal injury to me and/or my minor children who undertake such activity, and that a horse, irrespective of its training and usual past behavior and characteristics may act or react unpredictably at times, based upon instinct or fright, which, likewise is an inherent risk assumed by an individual riding a horse or riding in a horse drawn sleigh, cart or wagon.
3. I further understand that certain risks are normally involved in equine activities including but not limited to collisions, falls and equipment failure and that I or my children may suffer accidents or illnesses in remote places where there are no available medical facilities; and that no warranty of any kind, expressed or implied is being made as the habits, disposition, suitability, nature or physical condition of any animal. I also realize that participation in an equine activity can result in personal injury, accidents and/or illness including but not limited to sprains, broken bones, paralyses, dismemberment or death as well as damage to or loss of personal property.
4. I expressly assume the risks set forth above in paragraphs 2 and 3 on my behalf and on behalf of my minor child or ward and waive any claims based on negligence or breach of warranty that I or my minor child or children might have against Bruce Kindred, Kim Kindred, Kindred Spirits Farm, its owners, agents and employees as a result of or personal injuries or property damage incurred applicable to and binding on the minor child.
5. I understand that the signature of the parent or guardian of a minor child on this agreement shall make all provisions of this release and agreement applicable to and binding on the minor child.
6. In recognition of the inherent risks of the activity which I and any minor children for which I am responsible, will engage in, I confirm that I am (we are) physically and mentally capable of participating in the activity and using the animals and equipment.
7. I further agree to hold harmless, Bruce Kindred, Kim Kindred, Kindred Spirits Farm, its owners, agents and employees and to indemnify them for any personal injuries to others or for property damage which arises from my use of horses provided by Kindred Spirits Farm or my participation in equine activities involving riding or the use of horse drawn sleigh, cart or wagon.

I ACKNOWLEDGE HAVING READ THIS DOCUMENT AND UNDERSTAND THIS RELEASE AND AGREEMENT. I UNDERSTAND THAT BY SIGNING THIS AGREEMENT, I AM WAIVING CERTAIN LEGAL RIGHTS AND DO SO VOLUNTARILY.
